

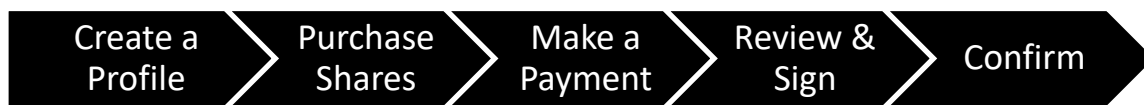


## How to Invest Guide



## Section 1: Sign up to use the Secured Investor Portal

**Step 1:** Go to [Integro Bank Investor Portal](#). Or, go directly to <https://www.integrobank.com/> and click on **Become an Investor** button.



**Step 6:** Select a payment method below. **Electronic Bank Payment** is the recommended option to expedite the payment without any manual process. Please note all payment types below require a **\$25** processing fees.

<p> <b>ELECTRONIC BANK PAYMENT</b></p> <p>Simple, Convenient, Secure. This method allows you to securely input your bank ABA Routing Number and Account Number from a Check for payments up to \$250,000.</p> <p><b>SELECT</b></p>	<p> <b>WIRE TRANSFER</b></p> <p>Suitable for large transactions above \$250,000, but requires a visit to your bank. This method has a higher rejection rate, as any minor typo will require a resubmission which may involve additional fees.</p> <p><b>SELECT</b></p>	<p> <b>CHECK BY MAIL</b></p> <p>This method is the slowest and least secure. 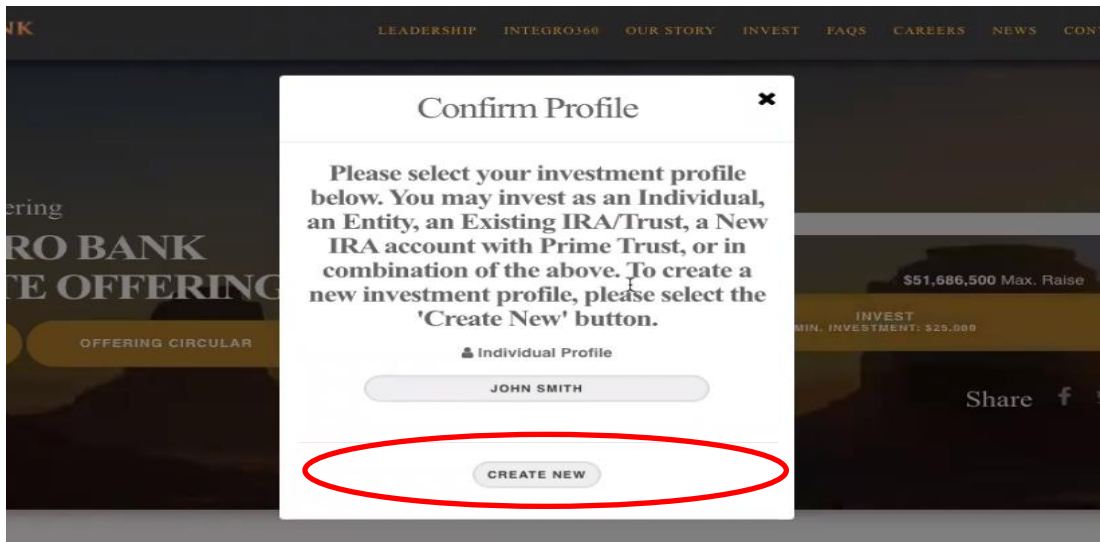

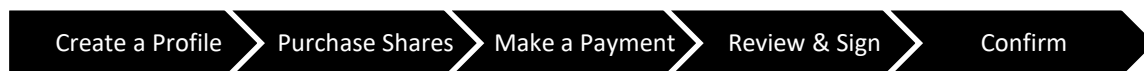
## Other Investment Options:

## SELECT PROFILE TYPE

You may invest as an Individual, an Entity, an Existing IRA/Trust, a New IRA account with AltoIRA, or in combination of the above with minimum of \$25,000 and maximum of \$2.47 MM (9.99% of minimal offering amount of 2,688,650 shares). Please note, if you intend to purchase some stock individually, some on behalf of a trust and purchase some on behalf of a self-directed IRA, you will need to establish a separate account on this portal for each purchase type since the name of the shares will be titled in different names. 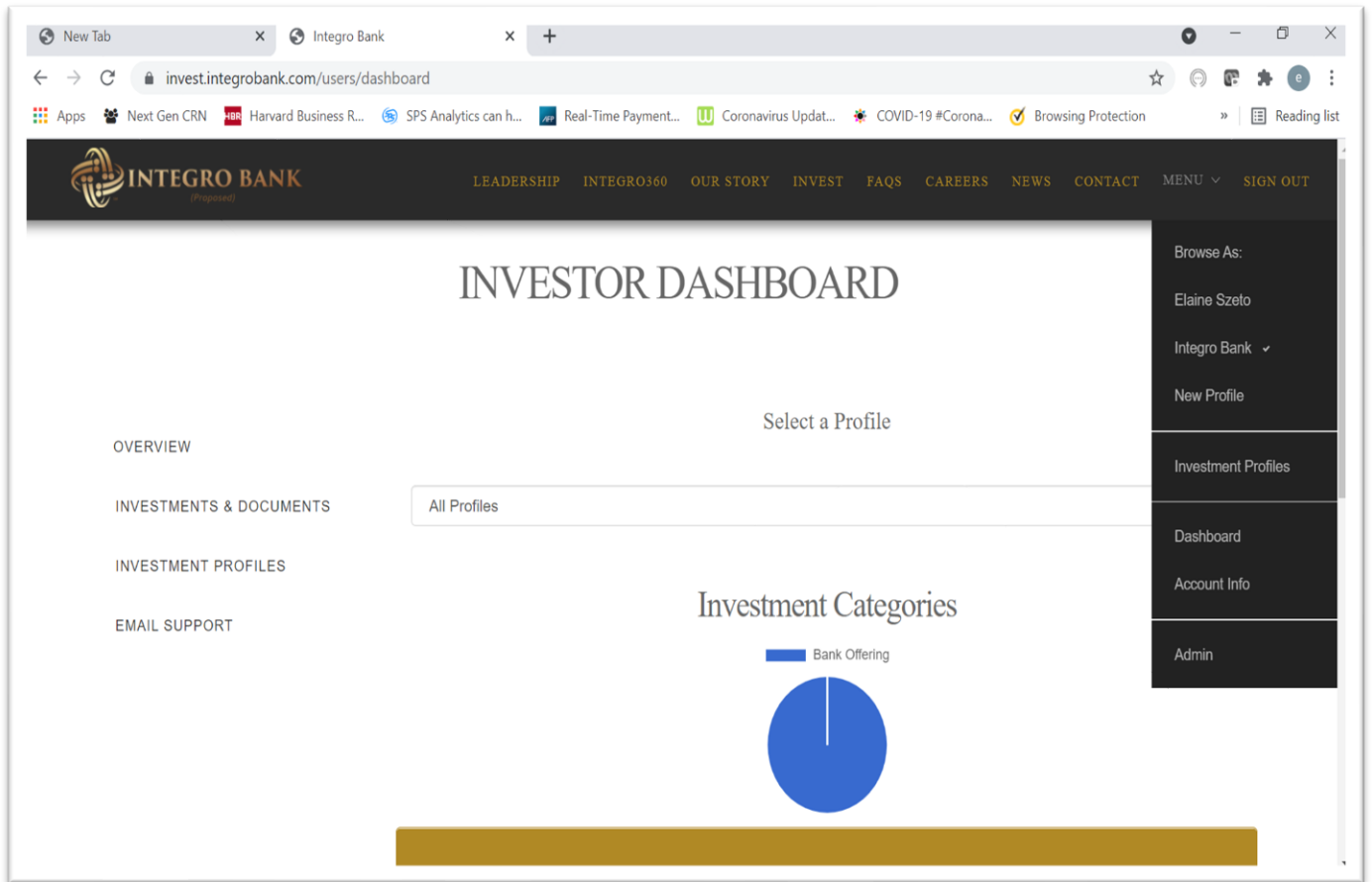
